Why we collect your personal information

We use your information to identify you, assess your credit worthiness, set up and manage your membership, accounts, Services, and relationship with Great Southern Bank, notify you about our Business+ Services and to undertake research and development. In many instances, collection of your information is required by law, for example, under the Corporations Act 2001, the Anti-Money Laundering and Counter Terrorism Financing Act 2006, and the Credit Reporting Code. Without collecting your information we may not be able to provide you with our Services.

We also use your information for other purposes, including keeping you informed about Services issued or distributed by Great Southern Bank and trusted third parties.

How we collect your personal information

We collect information directly from you and from third parties (those third parties are listed below) through:

- your application for, use, and access of Business+ Banking App or Business+ Banking Online, including through the chat function;
- your application for, use, and access of the Business+ Services;
- providers of any third party services that you have connected to Business+ Banking or that you may access through Business+ Banking;
- other third parties (for example, identity verification service providers, financial and cyber crime monitoring organisations and credit reporting bodies);
- customer representatives who support Business+ Banking Services; and
- other ways with your consent, permission or direction to do so.

Every time you apply for a Business+ Service we'll let you know what information we need and who we will collect it from.

Who we share information with

We may collect and disclose your personal information from and to third parties including:

- Our agents, assignees and contractors
- Our service providers including those used for identity verification, software/IT support, account management (including payments), mailing material to you, member and product research and accounting, legal and audit services

- A person acting on your behalf including a financial adviser, trustee, attorney or person you have granted a delegated authority
- Payment system operators, for example, to enable you to make payments or use the PayID service (noting that our third party payment system operators may disclose your Personal Information to their financial institution or payment processor, further details of which are covered in the Business Banking Terms and Conditions)
- Providers of any third party services that you have connected to Business+ Banking or that you may access through Business+ Banking
- Third party financial and cyber crime monitoring organisations to help prevent, detect and investigate suspicious, fraudulent, criminal or other activity that may cause you, us or others harm
- Your referees, employers and tax agents
- Government agencies, including the Australian Taxation
 Office and exchanged with tax authorities in other
 jurisdictions, as required
- Courts and dispute resolution schemes
- · Great Southern Bank Group entities
- Credit reporting bodies and other credit providers (including second mortgagees)
- Managers and funding providers of securitisation facilities
- Debt collection agencies, settlement agencies and valuers
- Guarantors, joint-borrowers and joint account holders
- Other financial institutions where required as a result of your use of the Services (for example, where you make a payment to a customer who holds an account with another bank)
